



## TERMS AND CONDITIONS

**Cancellation Policy:**

JDF Skating Club is not responsible for cancellation of classes due to unavailable ice but will make every effort to re-schedule in the event that this does happen.

**Refund Policy:**

Refunds and/or change of programs will be considered up until a week prior to the start of a program, however, there will be an administration fee of \$15. Please note that the Skate Canada Membership Fee is a NON-REFUNDABLE fee and thus there will be no reimbursement of this part of an invoice.

No refunds will be issued after the first day of skating unless there are medical circumstances. All requests for medical refunds must be submitted in writing to the JDF Skating Club Board of Directors and accompanying documents may be required.

**Sibling Discount:** 15% Sibling Discount is applied to registration fees for families registering more than 1 skater in their family. The discount is applied to the skater(s) with the lower registration fee total. Sibling discount cannot be applied/combined with pro-rated fees. The sibling discount is not applicable to CanPower registration fees.

**Pro-Rated Fees:** CanSkate/Pre-Power registration fees are prorated between November 1st to February 1st for the Fall/Winter Season. All Pre-Junior/Junior/Intermediate/Senior programs are pro-rated once on January 1st during the Fall/Winter Season. Pro-rated fees cannot be combined with the sibling discount. Pro-rated fees are not applicable to CanPower registration fees.

**Export:** We do not export any goods or services.

**Terms/Conditions for Registration:** In addition to general terms and conditions, you will be required to accept the policies as required by each particular program during your registration process.

**Privacy Policy:** In alignment with Skate Canada, JDF Skating Club understands the importance of privacy regarding the information we collect from our members. The purpose of collecting information from our members is to administer JDF Skating Club programs, register with Skate Canada and to communicate with members.
