Refund/Cancellation Policy: JDF Skating Club is not responsible for cancellation of classes due to unavailable ice but will make every effort to re-schedule, if at all possible. No refunds will be issued after the first day of skating unless for medical circumstances. All requests for medical refunds must be submitted in writing and accompanying medical documents may be required. All refunds are at the discretion of the JDF Skating Club Board of Directors (Skate Canada Membership Fee is Non-Refundable).

Sibling Discount: 15% Sibling Discount is applied to registration fees for families registering more than 1 skater in their family. The discount is applied to the skater(s) with the lower registration fee total. Sibling discount can not be applied/combined with pro-rated fees. The sibling discount is not applicable to CanPower registration fees.

Pro-Rated Fees: CanSkate/Pre-Power registration fees are prorated between November 1st to February 1st for the Fall/Winter Season. All Pre-Junior/Junior/Intermediate/Senior programs are pro-rated once on January 1st during the Fall/Winter Season. Pro-rated fees can not be combined with the sibling discount. Pro-rated fees are not applicable to CanPower registration fees.

Export: We do not export any goods or services.

Terms/Conditions for Registration: In addition to general terms and conditions, you will be required to accept the policies as required by each particular program during your registration process.
